BE IT ORDAINED by the Council of the City of Cleveland Heights, Ohio, that:

This Council hereby approves the proposed First Amended Charter and authorizes and directs the submission to the electors of the City of Cleveland Heights, at the general election to be held at the usual places of voting in said City on Tuesday, November 5, 2019, the proposed First Amended Charter of the City of Cleveland Heights, attached hereto and incorporated herein as “Exhibit A.”

SECTION 2. The Cuyahoga County Board of Elections is hereby directed to submit the following question to the electors of the City of Cleveland Heights at the general election on Tuesday, November 5, 2019 in substantially this form:

PROPOSED CHARTER AMENDMENT

A majority affirmative vote is necessary for passage.

“Shall the proposed First Amended Charter of the City of Cleveland Heights, as approved by the City Council of the City of Cleveland Heights, Ohio, be adopted? ___ Yes ___ No”

SECTION 3. The Clerk of Council is hereby instructed to file forthwith a certified copy of this Ordinance and the proposed form of the ballot question with the Cuyahoga County Board of Elections not less than sixty (60) nor more than one hundred twenty (120) days prior to November 5, 2019, for the Board’s processing in the manner provided by the general laws of the State of Ohio.

SECTION 4. The Clerk of Council is hereby directed to provide notice of the proposed First Amended Charter pursuant to Article VIII-5 of the Charter of the City of Cleveland Heights, by either: (1) printing or mailing to each registered elector an official publicity pamphlet, or (2) publicizing official publicity in a newspaper published and generally circulated in the City, or if no such newspaper is published in the City, then in a newspaper of general circulation within the City, at least once a week for not less than two consecutive weeks with the first publication being at least thirty (30) days prior to November 5, 2019. Such publicity pamphlet or publication shall contain a full text of the proposed First Amended Charter, with the respective ballot title(s), together with any explanation or argument for or against such measure

which may have been filed with the Clerk of Council.

SECTION 5. If the majority of electors voting thereon vote in favor of adopting the First Amended Charter of the City of Cleveland Heights, it shall become effective January 1, 2020 or as otherwise provided therein, and all prior charters shall be repealed, except as may otherwise be provided in such First Amended Charter.

SECTION 6. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health and safety of the inhabitants of the City of Cleveland Heights, such emergency being the timely need to meet Board of Elections deadlines. Wherefore, provided it receives the affirmative vote of five (5) or more members elected or appointed to this Council, this Ordinance shall take effect and be in force immediately upon its passage; otherwise, it shall take effect and be in force from and after the earliest time allowed by law.

This Council hereby approves the proposed First Amended Charter and authorizes and directs the submission to the electors of the City of Cleveland Heights, at the general election to be held at the usual places of voting in said City on Tuesday, November 5, 2019, the proposed First Amended Charter of the City of Cleveland Heights, attached hereto and incorporated herein as “Exhibit A.”

SECTION 2. The Cuyahoga County Board of Elections is hereby directed to submit the following question to the electors of the City of Cleveland Heights at the general election on Tuesday, November 5, 2019 in substantially this form:

PROPOSED CHARTER AMENDMENT

A majority affirmative vote is necessary for passage.

“Shall the First Amended Charter of the City of Cleveland Heights be adopted, ~~(as proposed by City Council upon consideration of the recommendations of a Charter Review Commission as proposed by the charter review commission and revised by city council)~~ which retains the Council-Manager form of government; clarifies and strengthens the City Manager’s role as chief executive and Council’s responsibilities in evaluating the City Manager and in confirming senior administrative appointments; creates ethics requirements for city officials and employees; broadens equal opportunity and open government policies; modernizes provisions for handling and controlling City finances, including mandating an annual independent financial audit; removes outdated language and makes it gender neutral; limits the time ~~to fill~~ for council to fill vacancies; and limits the number of years that can pass without a charter review?”

SECTION 3. The Clerk of Council is hereby instructed to file forthwith a certified copy

of this Ordinance and the proposed form of the ballot question with the Cuyahoga County Board of Elections not less than sixty (60) nor more than one hundred twenty (120) days prior to November 5, 2019, for the Board’s processing in the manner provided by the general laws of the State of Ohio.

SECTION 4. The Clerk of Council is hereby directed to provide notice of the proposed First Amended Charter pursuant to Article VIII-5 of the Charter of the City of Cleveland Heights, by either: (1) printing or mailing to each registered elector an official publicity pamphlet, or (2) publicizing official publicity in a newspaper published and generally circulated in the City, or if no such newspaper is published in the City, then in a newspaper of general circulation within the City, at least once a week for not less than two consecutive weeks with the first publication being at least thirty (30) days prior to November 5, 2019. Such publicity pamphlet or publication shall contain a full text of the proposed First Amended Charter, with the respective ballot title(s), together with any explanation or argument for or against such measure which may have been filed with the Clerk of Council.

SECTION 5. If the majority of electors voting thereon vote in favor of adopting the First Amended Charter of the City of Cleveland Heights, it shall become effective January 1, 2020 or as otherwise provided therein, and all prior charters shall be repealed, except as may otherwise be provided in such First Amended Charter.

SECTION 6. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health and safety of the inhabitants of the City of Cleveland Heights, such emergency being the timely need to meet Board of Elections deadlines. Wherefore, provided it receives the affirmative vote of five (5) or more members elected or appointed to this Council, this Ordinance shall take effect and be in force immediately upon its passage; and further provided that an affirmative vote of five (5) or more members of Council is required for adoption pursuant to Charter Article XIII.
