ORDINANCE NO. 20-2015 (CRR), *Second Reading*

By Council Member

An Ordinance establishing use regulations and rates for admission and other services for Cumberland Swimming Pool; and repealing Ordinance No. 197-2013.

BE IT ORDAINED by the Council of the City of Cleveland Heights, Ohio that:

SECTION 1. ADMISSION AND USE - CUMBERLAND POOL

(a) Except as otherwise provided herein, admission to the Cumberland Swimming Pool and the use of such pool or any of the related facilities or activities provided for or conducted therein shall be limited to bona fide legal residents of the City of Cleveland Heights who are authorized holders of a proper Recreation Identification Card issued by the City of Cleveland Heights, or an authorized guest of the holder of such a Recreation Identification Card.

(b) Recreation Identification Cards shall be issued only to Cleveland Heights residents. The cost for Recreation Identification cards shall include a digital computerized photo provided by the City.

(c) Each holder of a Recreation Identification Card shall be entitled to purchase guest tickets for each public swimming session. Such guest tickets shall not be resold and shall be used only for bona fide guests of the Recreation Identification Card holder. Any such guests under age 18 shall be accompanied by the Card holder. The number of permitted guests may be reduced at any time by the Director of Community Services if she determines that such a reduction is required for the purposes of safety.

(d) (1) During periods when Cumberland Pool is not open for scheduled public use, it may be rented for private group use subject to approval and scheduling by the City Manager. The City Manager is authorized to establish and enforce reasonable regulations governing such group use.

(2) The group-use rental charge shall be Three Hundred Fifty Dollars (\$350.00) at Cumberland Pool for a basic period of two (2) hours or any fractional part thereof. These rates shall be increased proportionately for any period of time assigned beyond two (2) hours at Cumberland Pool.

(3) Group-use rental fees shall be paid to the City of Cleveland Heights at the time the sponsor reserves the pool.

(4) No group rental shall be approved unless the group desiring to rent the facility is sponsored by an adult resident of Cleveland Heights who is also the holder of a Recreation Identification Card. Only such sponsor shall negotiate rental and other arrangements. Such sponsor shall be responsible for the payment of rentals and for the conduct of members of the group while so using the pool facilities, shall be personally present during the entire period of such use, and shall be responsible to the City of Cleveland Heights for any damage or injury which may be caused by the group or any member thereof during the period of such use. Not less than sixty percent (60%) of the members of the group shall be residents of the City of Cleveland Heights.

(5) No group sponsor shall act as sponsor for more than one (1) group in any one season.

(e) (1) A Family Plan Season Pass shall entitle the following persons in the family to seek admission at any general swimming session, provided that each individual seeking admission pursuant to such Family Pass shall also be the owner of an individual Recreation Identification card:

Adult head of household and his/her spouse or partner.

Dependent Children, occupying the household, age 18 and under.

(2) Family swim sessions shall be limited to families consisting of an adult head of household and/or his/her partner or spouse and dependent children age 18 and under occupying the household.

(f) Replacement of a lost or mutilated Season Pass or Family Plan Season Pass will be made by the City upon payment to the City of a fee of Six Dollars (\$6.00). Replacement of a lost or mutilated Recreation Identification Card will be made by the City upon payment to the City of a fee of Six Dollars (\$6.00).

(g) (1) Learn-to-Swim and other instructional sessions may be scheduled by the City Manager during appropriate hours.

(2) Groups scheduled for Group Instruction shall be of such number of persons as is approved by the City Manager. Each member of any such group shall be a bona fide resident of the City of Cleveland Heights and the owner of a Recreation Identification Card or Season Pass; provided, however, that the City Manager may authorize any such group to include non-residents.

(3) The fees hereafter established for Group Instruction are based upon three (3), three-(3) week series of four (4) daytime instruction sessions per week and one (1) eight-(8) week series of two (2) evening sessions per week, and shall be adjusted proportionately by the

City Manager in the event any such series is schedule for a greater or lesser number of sessions. Preschool and adult lessons are scheduled to meet once a week for eight (8) weeks.

(h) The City Manager is hereby authorized to establish administrative and safety rules and regulations not inconsistent with the provisions of this Ordinance which she may, from time to time, deem necessary to provide for the orderly operation of the swimming pool and the conduct and protection of the members of the general public using same.

(i) The City Manager is hereby authorized to change facility dates, programs, sessions, and fees due to changes in the Cleveland Heights-University Heights school year dates, staffing shortages, or for other good cause, in her sole discretion.

SECTION 2. RATES AND CHARGES – CUMBERLAND POOL.

Except as otherwise provided herein, the use of the facilities at Cumberland Pool shall be limited to residents of the City of Cleveland Heights, and the following rates of admission and other charges are hereby established for the 2015 season at said Pool:

(a) Recreation Identification Card (includes computerized digital photo)..... \$5.00

(b2) A limited number of family passes will be available for non residents at \$172; a limited number of individual adult passes will be available for non residents at \$75; a limited number of individual student passes will be available for non residents at \$52. The sale of non resident passes shall in no way limit the use of the pool by residents.

SECTION 3. ADMISSION TICKETS AND PASSES – CUMBERLAND POOL.

Season Passes and General Admission Tickets will be sold only to:

- (a) Residents of Cleveland Heights who, except for those persons enumerated
in the following subsections (b) and (c), shall also be the authorized
holders of a proper Recreation Identification Card issued by the City of
Cleveland Heights.
- (b) Children enrolled in Summer Camps under the supervision of the Division
of Parks and Recreation of the City of Cleveland Heights – general
admission only.
- (c) Children enrolled in Day Camp groups which originate in the City of
Cleveland Heights, wherein at least seventy-five percent (75%) of the
membership of such groups are residents of the City of Cleveland Heights

SECTION 4 . SPLASH PAD REGULATIONS

- (a) Preschoolers and children under 48 inches in height are permitted to use the Splash Pad in Cain Park when accompanied by a parent/adult (18 and older) with a Cleveland Heights Recreation ID card
- (b) Adults must present their Cleveland Heights ID card to the staff member on duty.

SECTION 5. Ordinance No. 197-2013, passed on December 16,2013 is hereby repealed to the extent inconsistent herewith.

SECTION 6. Notice of the passage of this Ordinance shall be given by publishing the title and abstract of its contents, prepared by the Director of Law, once in one newspaper of general circulation in the City of Cleveland Heights.

SECTION 7. This Ordinance shall take effect and be in force at the earliest time possible permitted by law.
